DECISIONS OF GENERAL ASSEMBLY

Dağcılar Sitesi 2015-2016 General Meeting was held on Sunday, 10th July 2016 at 10:00 a.m in the site cafeteria, and the following decisions were made:

As there were 73 votes in total from site members the meeting was able to proceed. Elections of the council delegation were Chairman of the Council Ergün UZ, secretaryship; Ayla BELGİN; and Ümran YILMAZ.

Chairman of the Council, Ergün UZ made the following announcement before the meeting began:

In response to the court case and law suit initiated by Amanda Mary Jane JEWELL in relation to the General Meeting held on 8th July 2012 for the period 2011-2012 and the court's decision to rule that the meeting was null and void due to procedural issues in accordance with the court ruling in June 2014 (Principle No. 2012/298, Resolution No. 2014/359), a new vote was taken at today's meeting to uphold the decisions agreed at the General Meeting held on 8th July 2012, and was accepted.

Chairman of the Council, Ergün UZ passed the 2015-2016 Home Owners General Meeting on.

Remzi YILMAZ read the operating report and activities carried out during 2015- 2016 and was unanimously agreed and discharged.

Gülay İLKER read the Audit Report and was unanimously agreed and discharged.

The work to be held next year was discussed.

The following decisions were made and agreed:

1. It was agreed that the monthly site fee will be increased to 85 TL, with the usual 10% interest charge implemented for late payments.
2. Electric to increase to 50 krs per unit. Water to increase to 5 TL per m³ (per 1 unit), to cover the extra expenditure for daily water tank deliveries due to the fact that the well is running out (see point 3. below). There will now be a 10% interest charge implemented on late payments of electric and water bills to be applied monthly.
3. New water project was agreed to connect the site to the Belediye Water supply in the village. This will involve laying pipes from the village to each house on site and including new meters. 4 extra payments of 200 TL (totalling 800 TL) to be collected from each home owner in July, August, September and October 2016. Again a 10% interest charge will apply each month for late payment.
4. It was agreed that the members of the managing body will not pay monthly Site Fees and be allowed 50 TL towards electric and water monthly.
5. The election of the board members took place, and two lists were presented.
 1. Ümran YILMAZ, Mesut BERBEROĞLU, Julie ANNE BİCKERTON
 2. Burhan AYHAN, Julie ANNE BİCKERTON, Yavuz ATAThe second list got the overall vote of 48, and was selected. Remzi YILMAZ retired.
6. Candidates for the Supervisory Board and alternate members were Ergün UZ ve Bürge İter and Aliye POLAT were elected.
7. Wishes and requests were discussed.
